CONTRACTOR'S AGREEMENT PAGE

Contractor's Agreement

- 1) Applicator agrees to install the specified Thermo Manufacturing Systems, LLC, as outlined in the most current published specification guide, project specifications and/or as agreed upon and outlined in writing by Thermo Manufacturing Systems, LLC, for the project conditions.
- 2) Applicator agrees to comply with and understands the established following required warranty procedures as instituted by Thermo Manufacturing Systems, LLC:
 - a. Filing a completed **Job Start / Warranty Application** prior to the start of all projects. Inaccurate or incomplete forms may prevent Thermo Manufacturing Systems, LLC, from satisfying warranty requests. Further, it is understood and agreed that Applicator's filing of the completed Job Start / Warranty Application with Thermo Manufacturing Systems, LLC, does not automatically give rise to the issuance of a warranty (even if a warranty fee is paid). It is expressly understood and agreed that the filing of the completed Job Start / Warranty Application and payment of the warranty fee (as required below) merely initiates the warranty application process.
 - b. Filing a complete and accurate **Project Completion Form** upon the completion of the project. Until filed the project will not be considered complete and a warranty will not be issued by Thermo Manufacturing Systems, LLC.
 - c. Full payment of all materials and applicable warranty fees as outlined in the credit terms established by Thermo Manufacturing Systems, LLC's credit department. Non-payment will cause the warranty to be held until full payment is received, unless otherwise agreed upon by Thermo Manufacturing Systems, LLC's corporate office. Warranty fees are based upon full square quantities and rounded up to the next full square. Further, as set forth above, the payment of the warranty fee merely initiates the warranty process. No warranty shall be issued without full payment and the filing of all complete and accurate forms by the Applicator.
- 3) Applicator agrees that they will be responsible to Thermo Manufacturing Systems, LLC, for a period of 60 months after the date of issuance of the warranty. This includes supplying all labor to repair or replace any installation-related item of a Thermo Materials® product and any product or installation defect of a non-Thermo Materials® product that would become defective as determined by Thermo Manufacturing Systems, LLC. This includes, but may not necessarily be limited to, vapor retarders, roof insulations, adhesives, membrane base sheets, membrane interplies, membrane cap sheets or other surfacing, membrane flashings, roof cements, or other mastics or sealants, metal flashings at penetrations, and metal counterflashings or copings.
- 4) Applicator agrees to notify Thermo Manufacturing Systems, LLC, in writing, if any portion of the work is to be performed by subcontractors. Additionally, the Applicator agrees to be fully responsible for work performed by Applicator's subcontractors.

The above referenced information is true and accurate for application of the aforementioned project. Signature of this form indicates agreement to all terms contained herein, acknowledgment of all related copyrights and that all warranties or certifications are subject to the filing of all required forms as set forth herein, payment of all materials, fees, review, inspection and final approval by Thermo Manufacturing Systems, LLC, prior to issuance. The undersigned is an authorized employee of the submitting Applicator and shall be considered binding as the "Contractor" or Applicator itself.
